- **YOUR PAY MUST BE BY DIRECT DEPOSIT FROM YOUR EMPLOYER INTO AN ACTIVE CHECKING OR SAVINGS ACCOUNT IN YOUR NAME.**
- **YOU MUST BE ABLE TO SEND AND RECEIVE THE REQUIRED INFORMATION TO OUR TOLL FREE FAX.**

\*FUNDS CANNOT BE DEPOSITED INTO YOUR ACCOUNT ON WEEKENDS OR BANKING HOLIDAYS. IF YOUR LOAN IS APPROVED BY 1 AM EASTERN STANDARD TIME (EST) DURING THE WEEKDAYS, THEN IN MOST CASES THEY WILL BE DEPOSITED INTO YOUR ACCOUNT THE NEXT BUSINESS DAY. HOWEVER, IT COULD TAKE UP TO 48 HOURS BEFORE FUNDS BECOME AVAILABLE IN YOUR ACCOUNT. (EXAMPLE: IF YOUR LOAN IS APPROVED BY 1 PM (EST) ON FRIDAY THE SOONEST THE FUNDS WOULD BE AVAILABLE TO YOU WOULD BE MONDAY AND IN SOME CASES IT COULD TAKE UNTIL TUESDAY TO ARRIVE IN YOUR ACCOUNT.

\*\*THE AMOUNT OF THE ADVANCE WILL DEPEND ON YOUR INCOME AND ADVANCE HISTORY WITH THE MONEYTREE SERVICES, LLC.

YOU CAN APPLY ON-LINE OR YOU MAY PRINT THE APPLICATION THEN COMPLETE THE FORMS AND FAX IT ALONG WITH

1. **YOUR MOST RECENT COPY OF YOUR BANK STATEMENT (ALL PAGES). THIS STATEMENT MUST NOT BE OLDER THEN 30 DAYS. IF IT IS OLDER THEN 30 DAYS THEN YOU MUST ALSO PROVIDE THE STATEMENT ALONG WITH A PRINTOUT FROM YOUR BANK SHOWING YOUR ACCOUNT ACTIVITY SINCE THE DATE OF YOUR LAST STATEMENT.**
2. **A COPY OF YOUR MOST RECENT DIRECT DEPOSIT PAYROLL STATEMENT, STUB OR RECEIPT SHOWING DIRECT DEPOSIT INFORMATION.**
3. **COPY OF YOUR PHOTO I.D. (DRIVERS LICENSE, STATE I.D., PASSPORT, ETC.)**
4. **COPY OF YOUR PERSONAL CHECK.**
